OBJECTIVE

Seeks to outperform the Bloomberg Barclays US Intermediate Government/Credit Bond Index while maintaining a benchmark-aware risk return objective

HIGHLIGHTS

- Individual investment ideas are evaluated on the basis of their investment return potential and contribution to portfolio risk
- Top-down macro-analysis combined with bottom-up security selection drive portfolio construction
- Duration bands: +/- 1 year (typically +/- 0.25 year) relative to the index
- Typical portfolio: approximately 50 to 70 issuers, 70 to 90 issues
- All investments must be US dollar denominated
- Issuer maximum of 3% or benchmark weight plus 2% (whichever is greater at the time of purchase), Treasuries and GSEs excluded
- Industry maximum of 25% or the benchmark weight plus 10% (whichever is greater at the time of purchase)
- Investment universe typically includes US Treasuries, agencies, investment grade corporate bonds, Yankee bonds
