OBJECTIVE

Seeks to outperform the benchmark through security selection and sector allocation

HIGHLIGHTS

- Benchmark-aware strategy targeting a wide spectrum of securitized assets, including agency mortgage-backed securities (agency MBS) as well as investment grade asset-backed securities (ABS), commercial mortgage-backed securities (CMBS) and non-agency mortgage-backed securities (non-agency RMBS)
- Investment style combines a top-down approach to inter-sector allocation decisions and an active bottom-up security selection framework
- Investment strategy based on proprietary prepayment and credit research
- May only buy securities rated investment grade by at least one of the three major rating agencies (Moody's, Fitch or S&P) at the time of purchase
- Duration is typically managed +/- one year of benchmark duration
- Utilizes To-Be-Announced (TBA) securities
- No limit to out-of-benchmark allocations
- US dollar-denominated securities only
