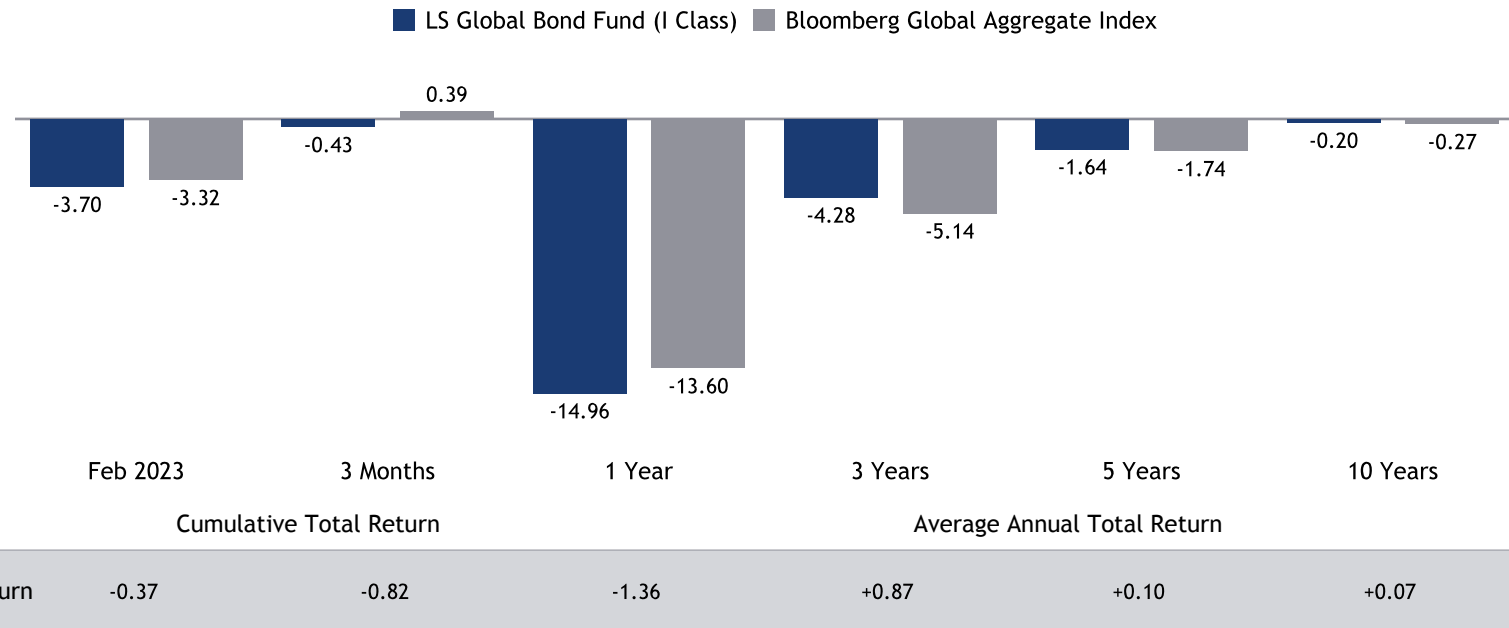

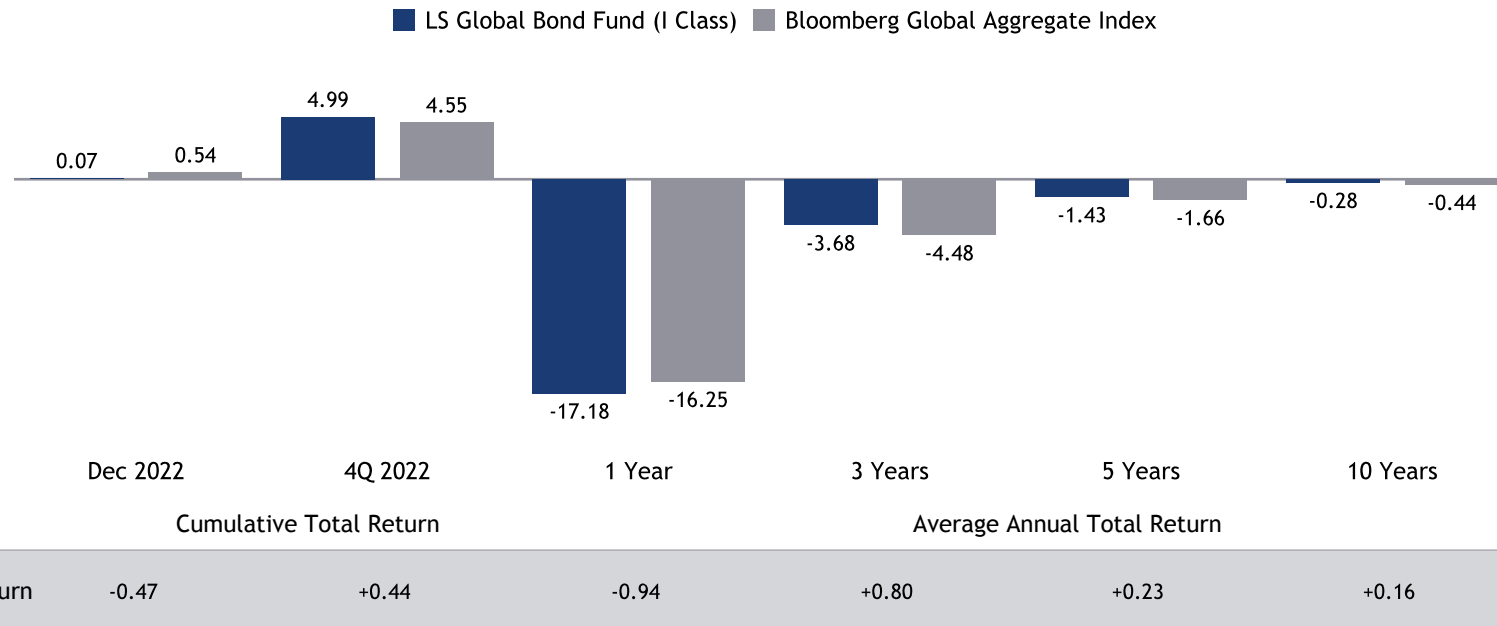

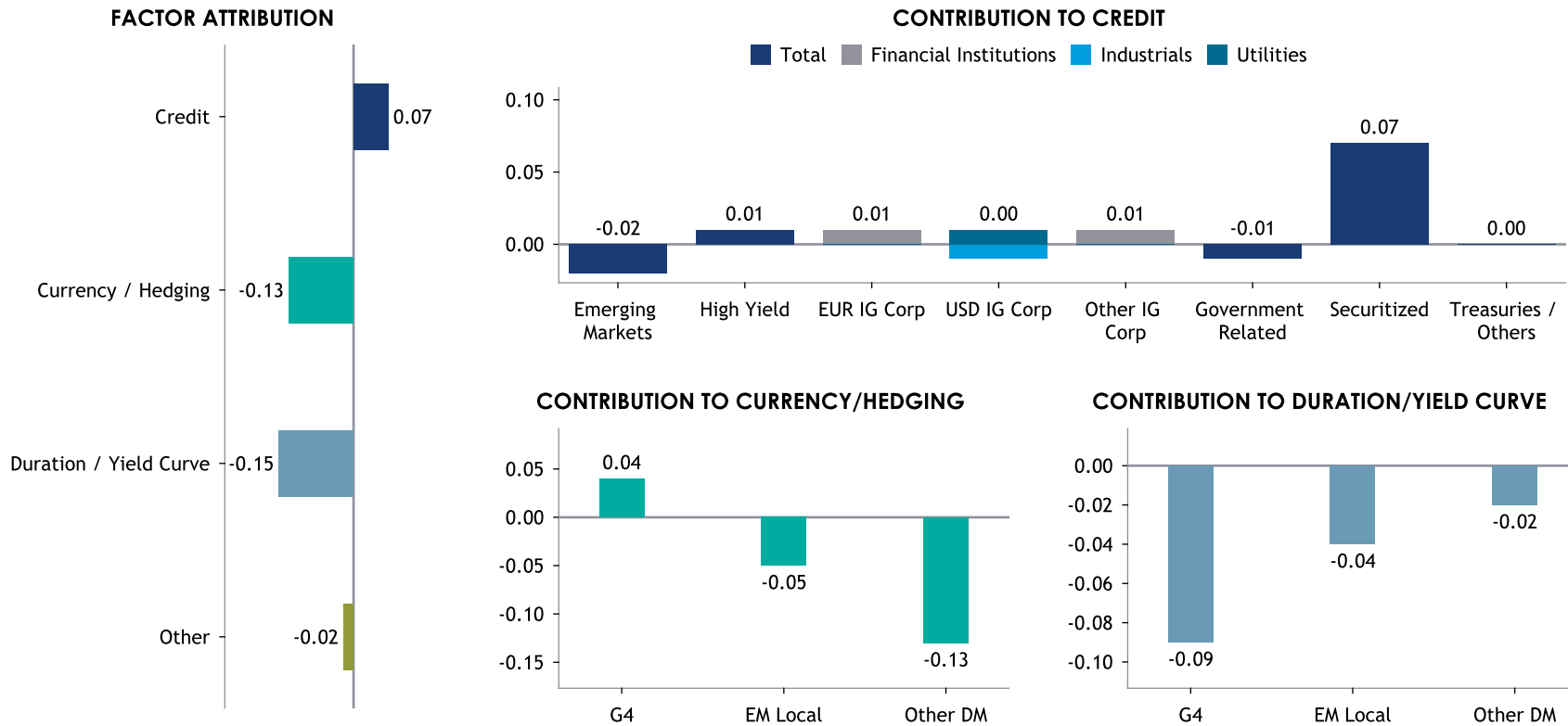

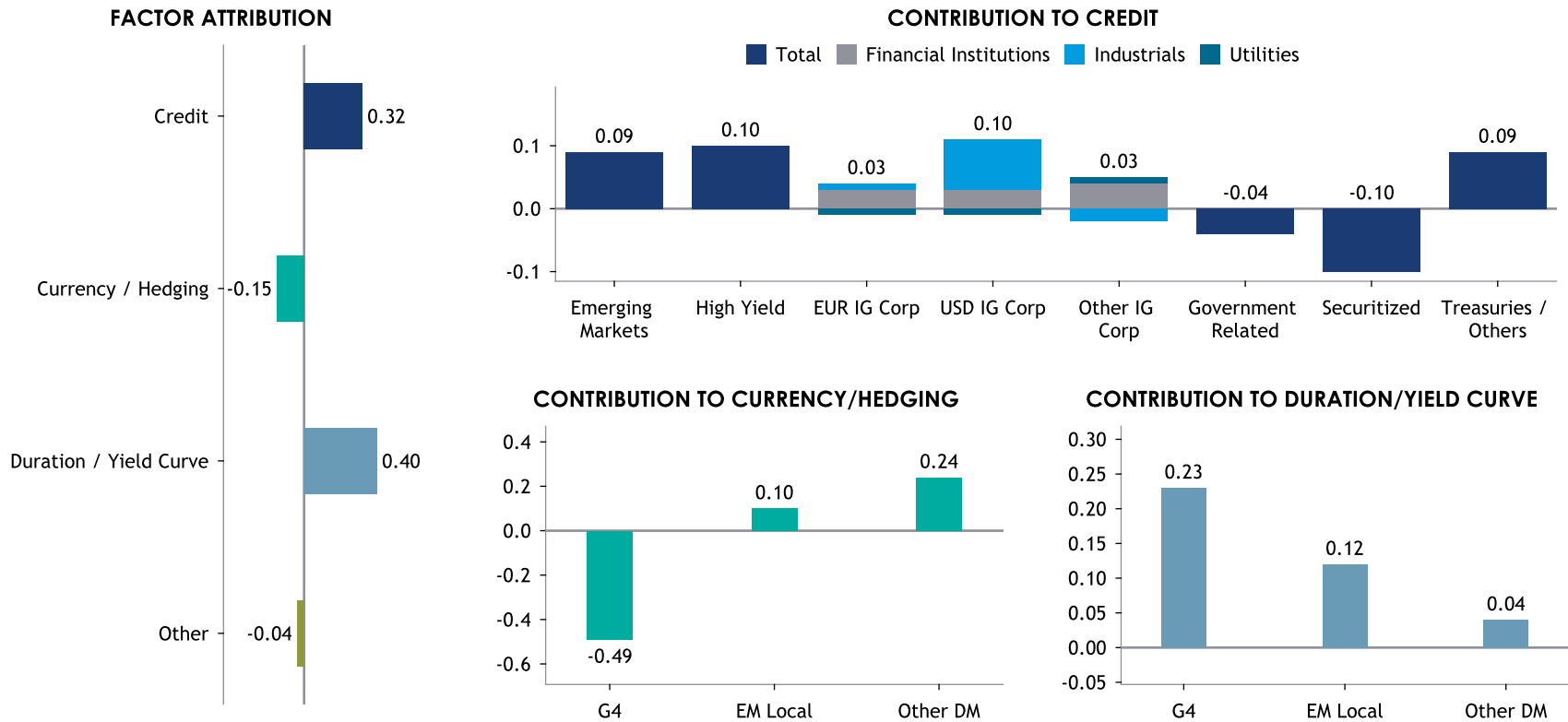

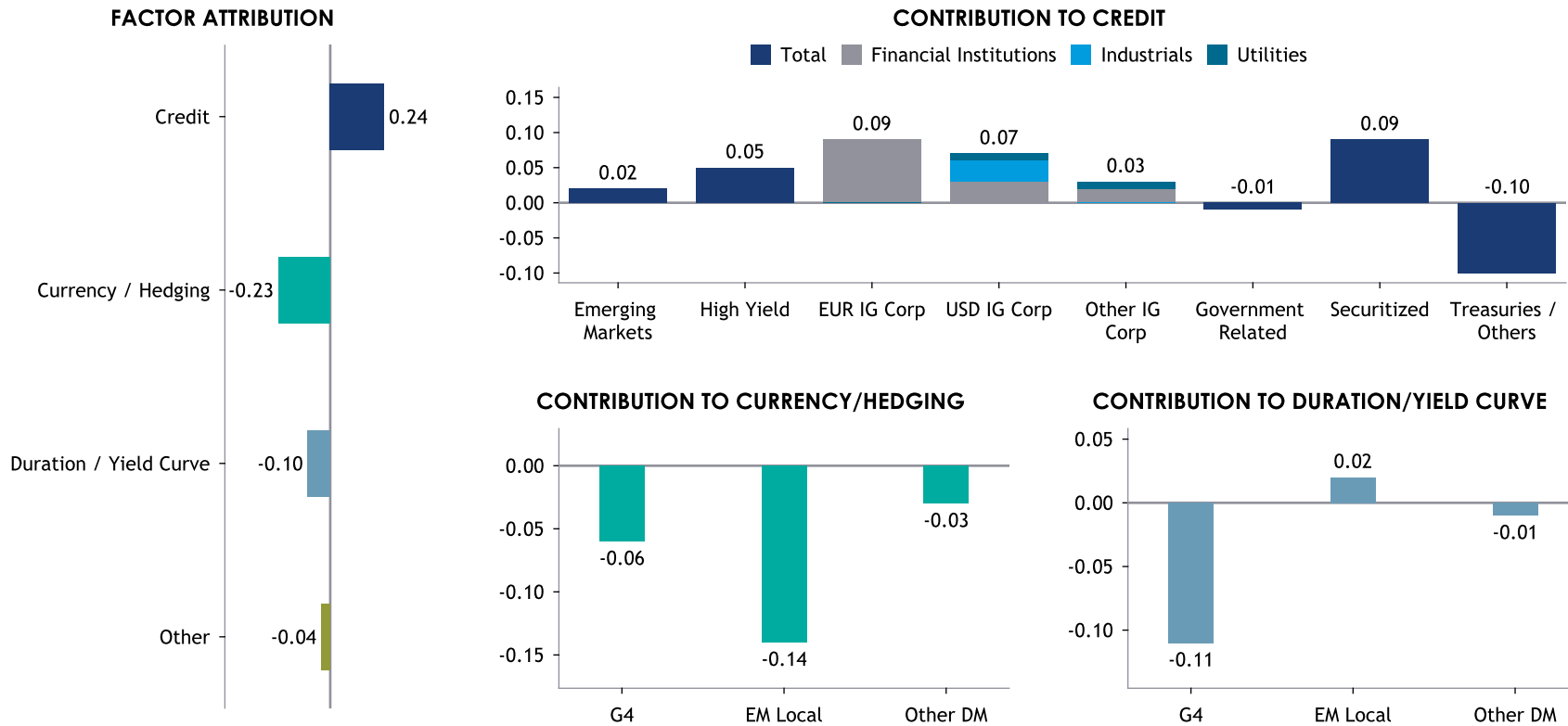

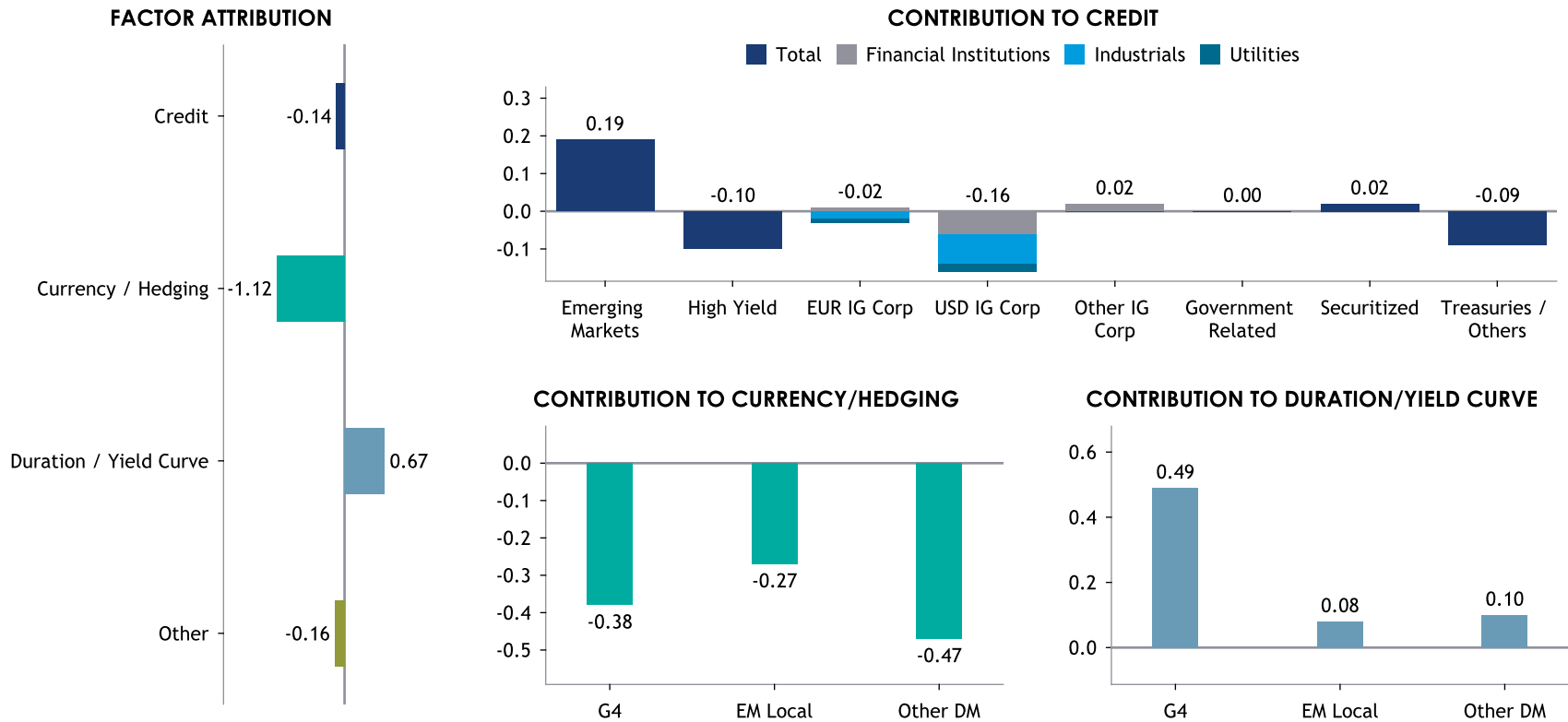

Additional Notes
