OBJECTIVE

Seeks current income consistent with preservation of capital to pursue higher yield potential in short duration yield securities

BENCHMARK

Bloomberg Barclays US Government/Credit 1-3 Year Index

HIGHLIGHTS

- Dynamic, active approach to sector allocation and security selection
- Individual investment ideas are evaluated on the basis of their investment return potential and contribution to portfolio risk
- Top-down macroeconomic analysis combined with bottom-up security selection drives portfolio construction
- Securities rated below investment grade are limited to 15% of the portfolio
- Duration is managed within a narrow range to the benchmark
- All investments must be US dollar denominated
- Investment universe typically includes US Treasuries, agencies, mortgage-backed securities (MBS), asset-backed securities (ABS), commercial mortgage-backed securities (CMBS), US and non-US domiciled investment grade corporate bonds, and below investment grade debt

The Bloomberg Barclays US Government/Credit 1-3 Year Index is the 1-3 year component of the Bloomberg Barclays US Government/Credit Index. The US Government/Credit Index includes securities in the Government and Credit Indices. The Government Index includes treasuries (i.e., public obligations of the US Treasury that have remaining maturities of more than one year) and agencies (i.e., publicly issued debt of US Government agencies, quasi-federal corporations, and corporate or foreign debt guaranteed by the US Government). The Credit Index includes publicly issued US corporate and foreign debentures and secured notes that meet specified maturity, liquidity, and quality requirements. Indices are unmanaged. The Investment Advisor has given a binding contractual undertaking to the Fund to limit the amount of the Fund's total annual fund operating expenses to 0.38% of the Fund's average daily net assets, exclusive of brokerage expenses, interest expense, taxes, acquired fund fees and expenses, organizational and extraordinary expenses, such as litigation and indemnification expenses. This undertaking is in effect through April 30, 2021 and may be terminated before then only with the consent of the Fund's Board of Trustees.

In addition, the Fund issues and redeems shares on a continuous basis only in large blocks of shares, typically 100,000 shares, called Creation Units.
