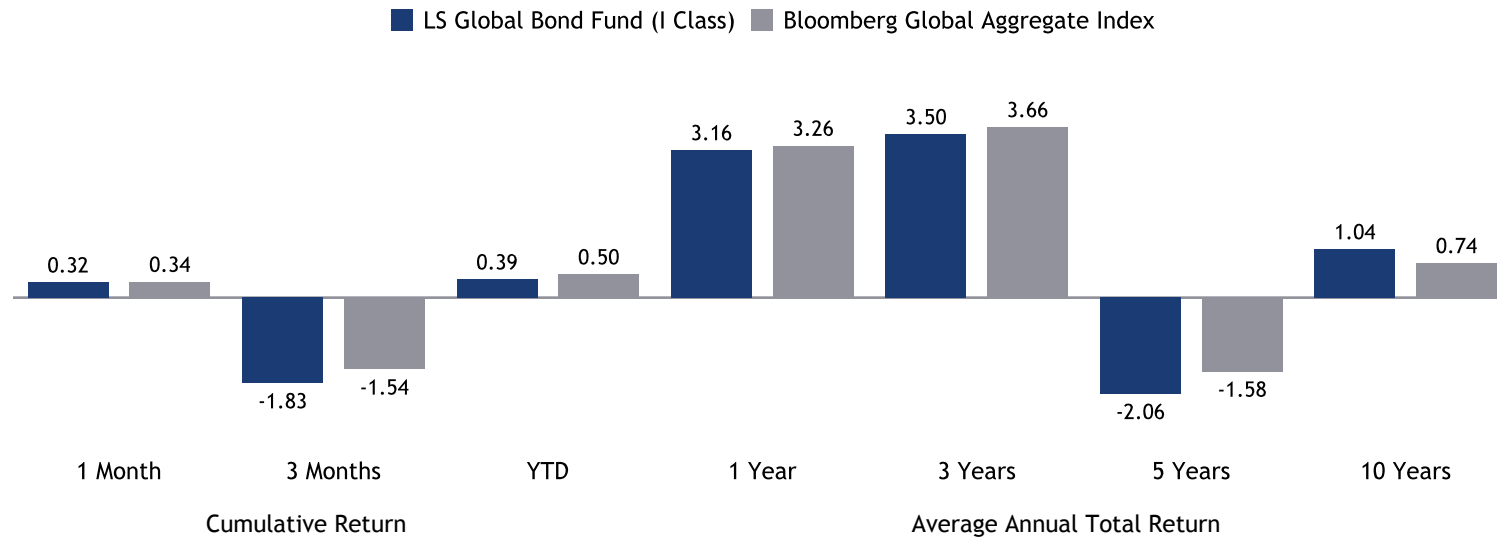

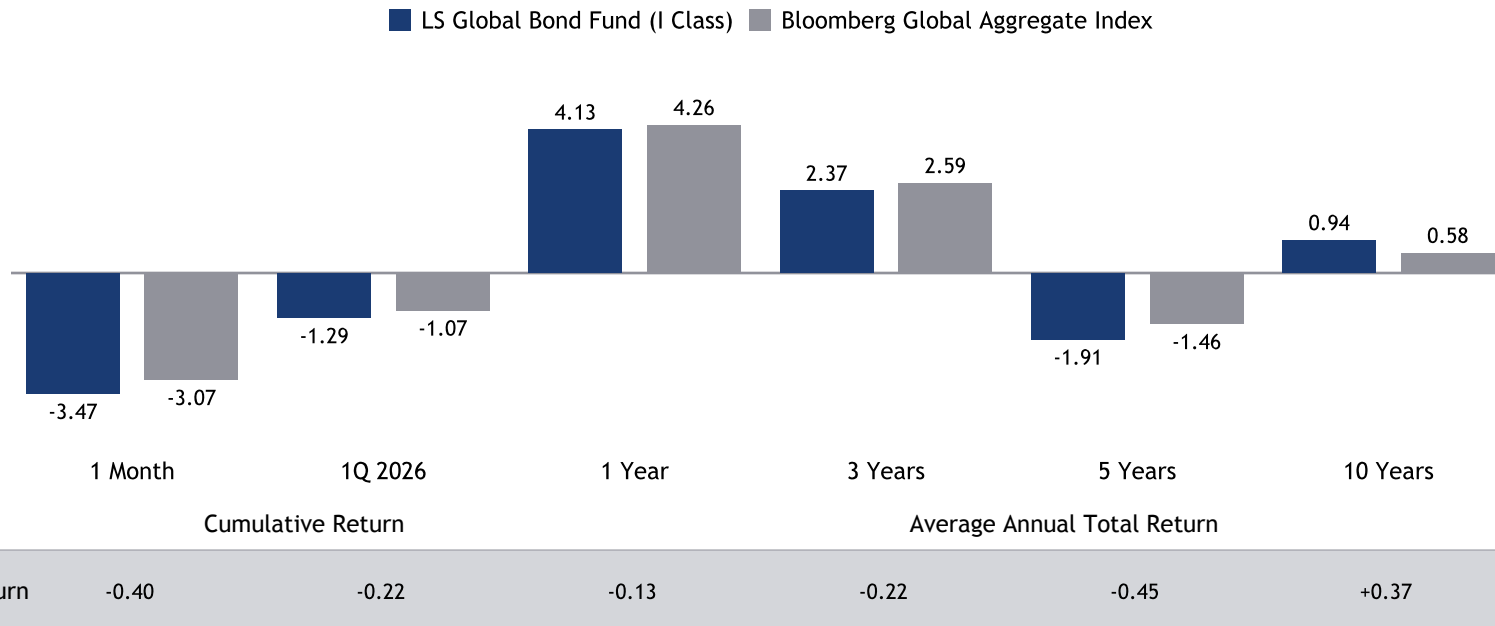

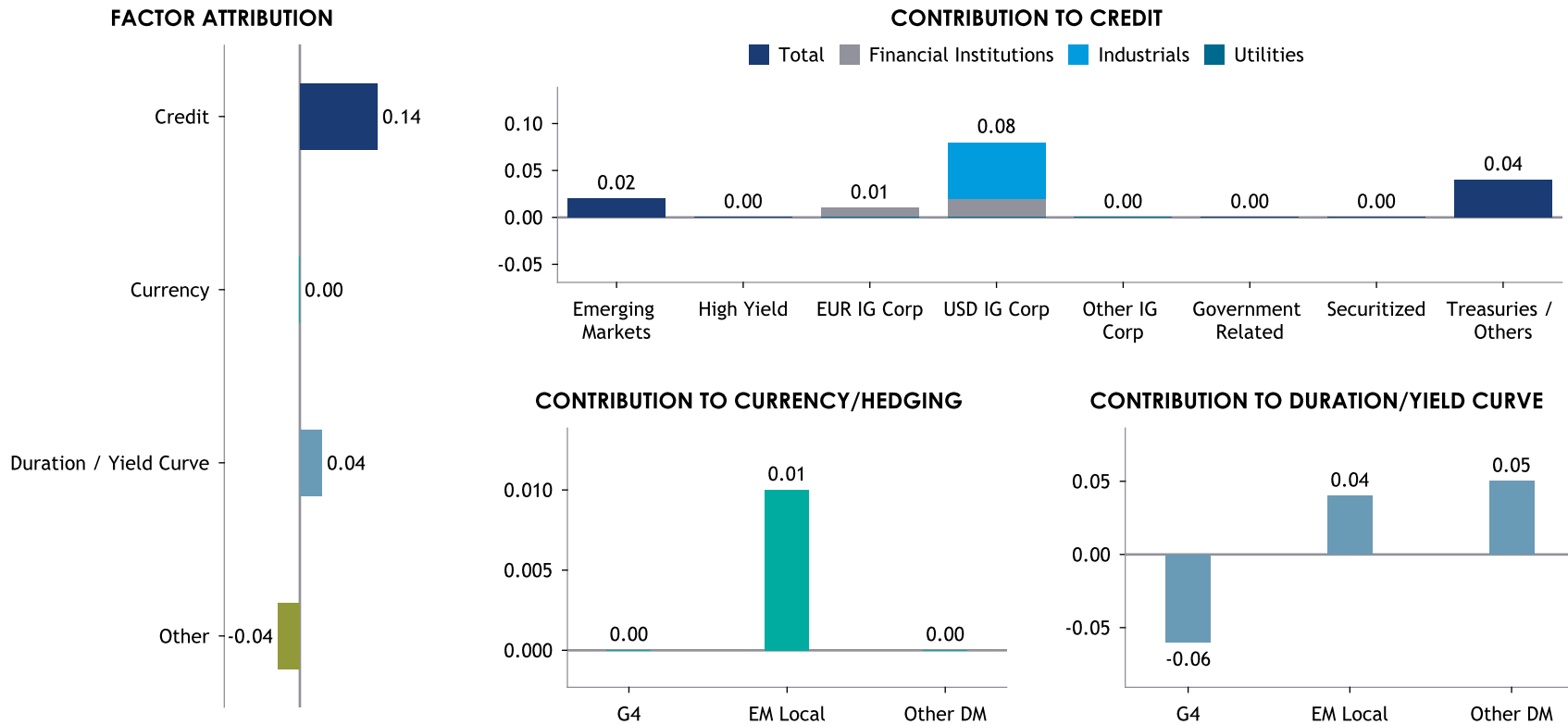

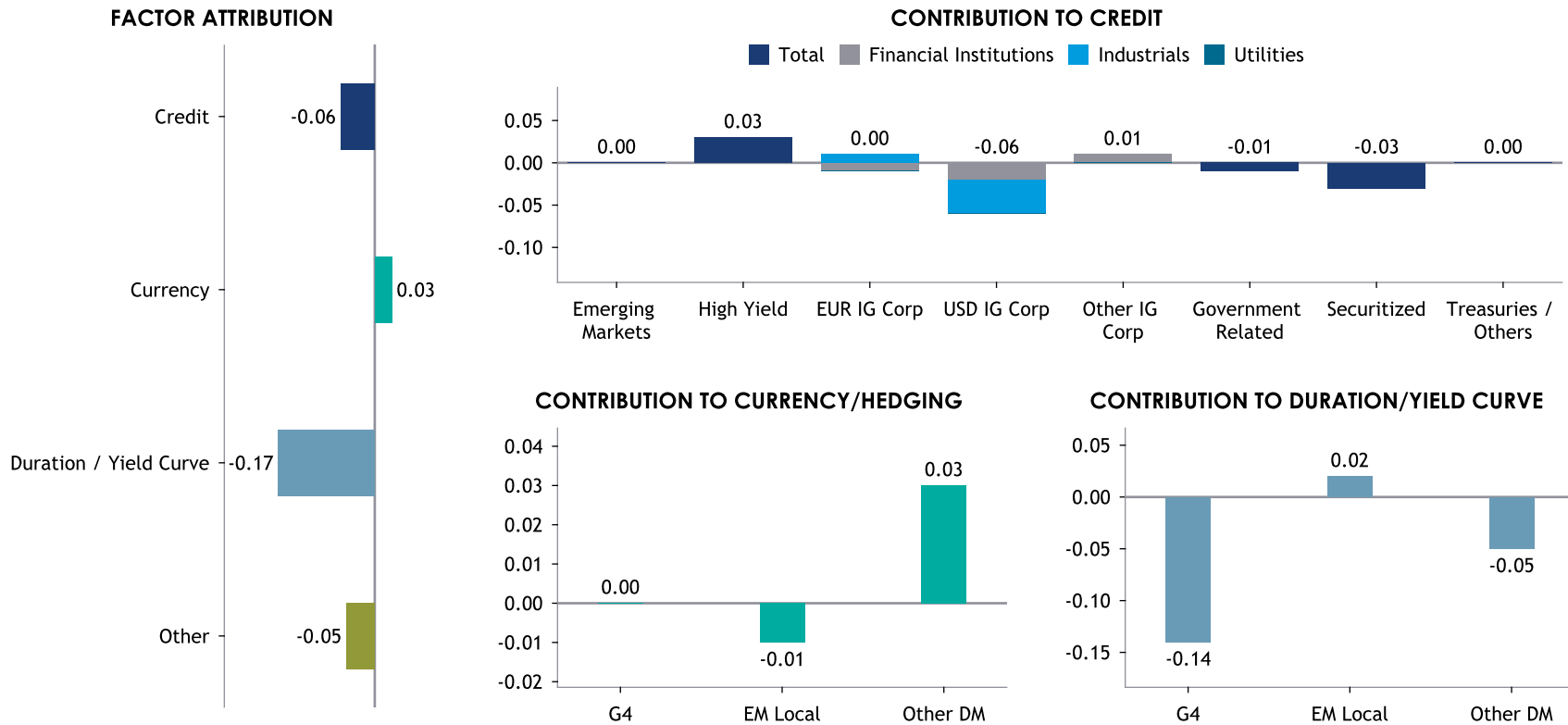

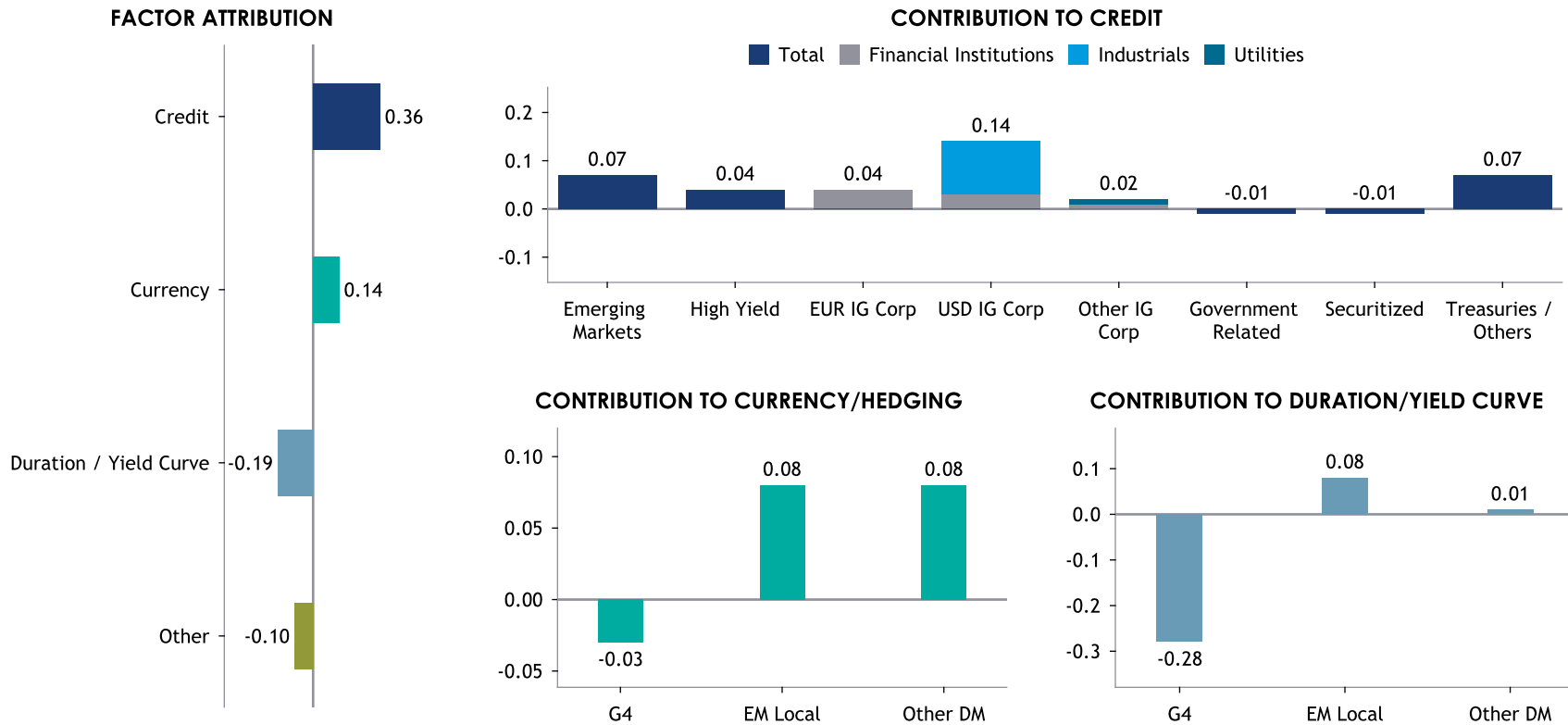

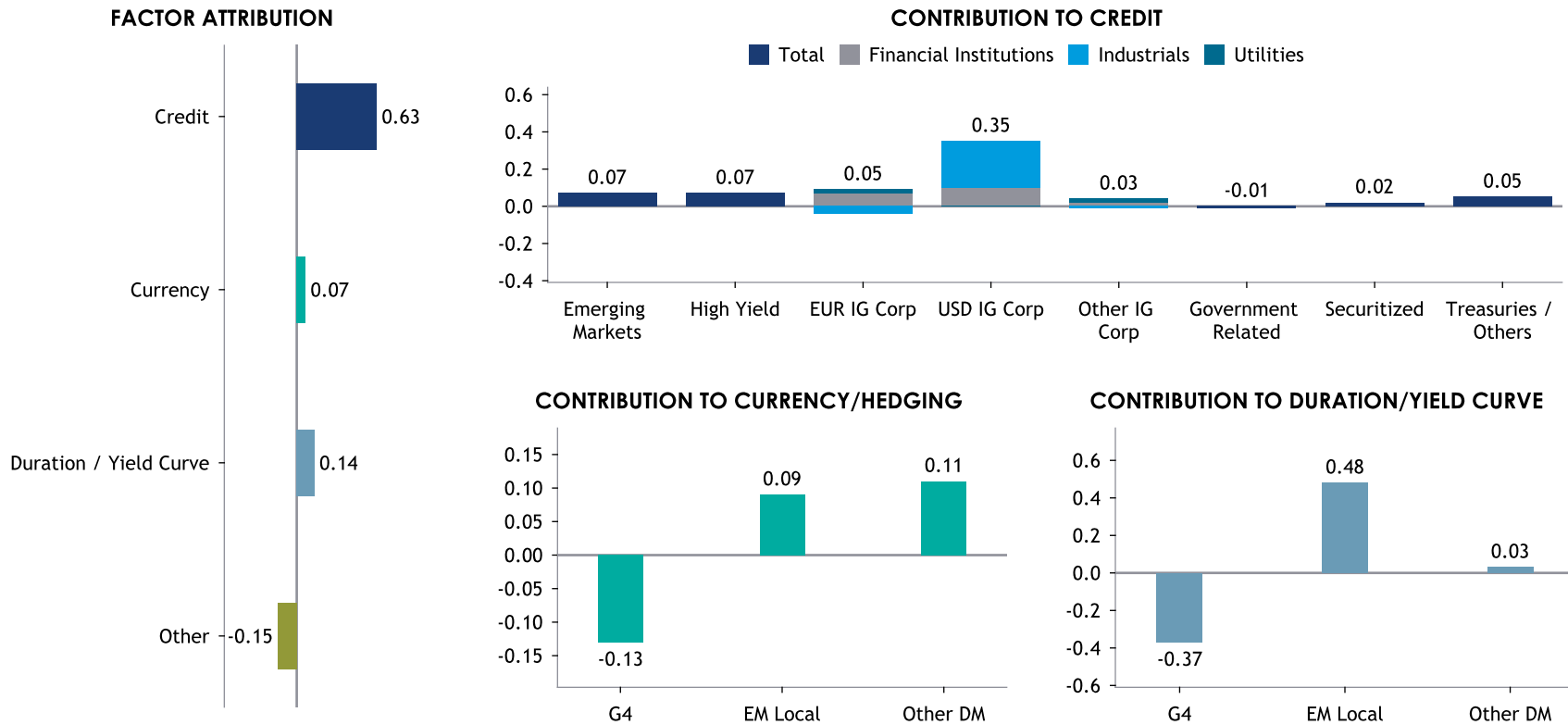

## Additional Notes
